## Terms and Conditions for the Kya Double with Supa Dupa Campaign

Stanbic Bank Uganda Ltd has rolled out the Kya Double with Supa Dupa Campaign (the Campaign) to reward customers who either transfer their salaries to their Stanbic Bank account, open a Stanbic Bank account and maintain an average account balance of UGX 500,000/= or reactivate their Stanbic Bank account and maintain an average account balance of UGX 500,000/= to stand a chance to win rewards as provided within these terms.

By participating in this campaign, you agree to be bound by these **Terms & Conditions**.

### 1. Eligibility

- 1.1 The campaign is open to Stanbic Bank Uganda customers above the age of 18 years, Stanbic Bank staff members shall not be eligible to participate in the campaign.
- 1.2 The campaign is available to both existing customers and new customers:
  - 1.2.1 New or existing customers who transfer their salaries to their Stanbic Bank account during the campaign period.
  - 1.2.2 New customers who open a Stanbic Bank account during the campaign period and maintain an average account balance of UGX 500,000/= for at least 1 calendar month during the campaign period.
  - 1.2.3 Existing customers who reactivate their existing Stanbic Bank accounts and maintain an average account balance of UGX 500,000/= for at least 1 calendar month during the campaign period.
- 1.3 Customers' bank accounts must be fully compliant with all the prevailing Stanbic Bank Uganda Limited standards and requirements.
- 1.4 Employees of Stanbic Bank Uganda Limited and its affiliates are ineligible to participate in the **Kya Double with Supa Dupa Campaign**.

### 2. Campaign Period

The campaign shall run from **15<sup>th</sup> May 2025** and ends on **31<sup>st</sup> October 2025** unless otherwise extended or terminated in accordance with these terms and conditions.

#### 3.1 Double Your Dimez Prize

Stanbic customers who qualify under either of the criteria set out under clause 1 stand a chance to double their average account balance as at the date of selection. Any reward pursuant to this clause shall not exceed UGX 5,000,000/=.

#### 3.2 Cashback Rewards

Stanbic customers who take up additional products (loans, credit cards, insurance, savings, investments) may get a cashback of up to UGX 100,000.

#### 3.3 Digital Transactions Incentives

Stanbic customers paying bills digitally may get a cashback of up to UGX 20,000.
